The St Lucie County Pretrial Release Program is funded through the St Lucie County Board of County Commissioners, under the office of the County Attorney, with direct supervision of the St Lucie County Criminal Justice Coordinator.

The St. Lucie County Pretrial Release Program has been staffed by county employees since June 2007. Although initially started to provide supervision of pretrial defendants and to alleviate jail over-crowding, it has provided supervision of other cases when ordered by the Judiciary. Since the Program provides enhanced supervision (including GPS monitoring), defendants have been sanctioned from Drug Court, defendants have been referred from Mental Health Court while pending evaluations, a few have been ordered under supervision while pending appeal, and a number of defendants are ordered to the Program while their case is pending for Violation of Probation (both circuit and county). In addition, the Program has a minimal number of defendants that have been sentenced to "house arrest" as an alternative to county jail, and this may be considered as an area of future expansion.

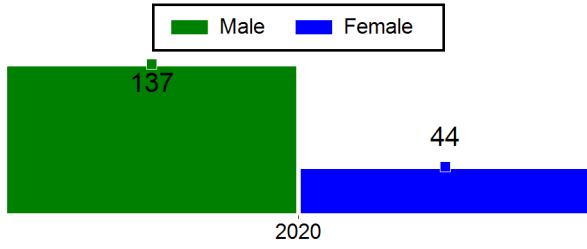

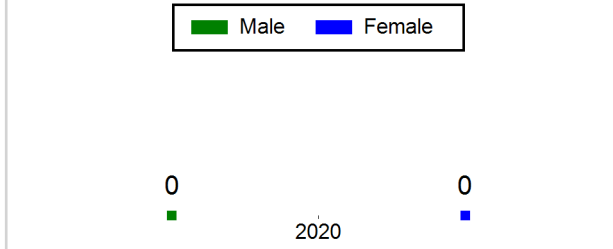

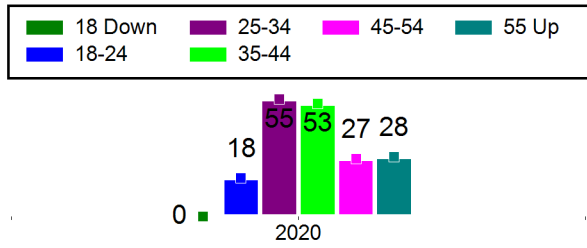
### Male and Female Defendants on Pretrial



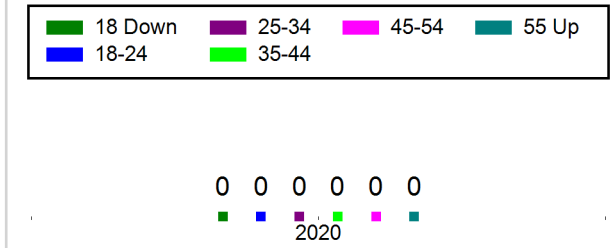
### Male and Female Defendants - Sentenced



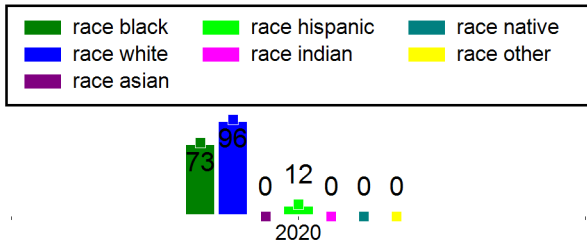
### Age Profile of Defendants on Pretrial



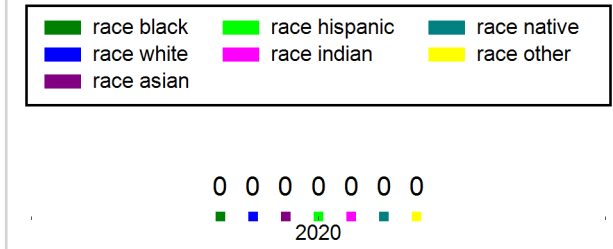
### Age Profile of Defendants - Sentenced
